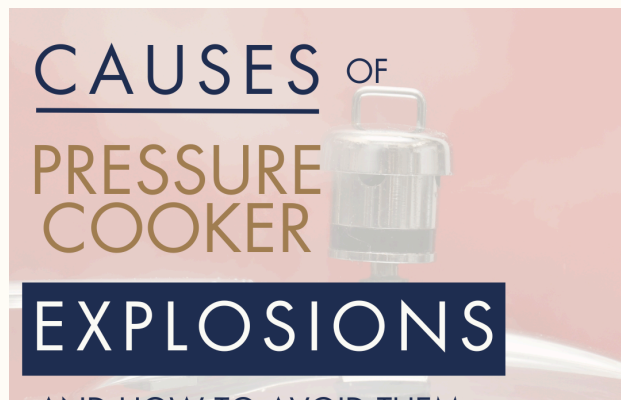


WOMEN'S HISTORY MONTH 2024

Erin personifies the relentless spirit of this firm in her wholehearted devotion to every single family affected by this tragedy. She has worked around the clock fueled by her desire to hold the proper parties accountable and be the voice for every victim. Her hard work, though just beginning, has already paid off with this settlement with the city of Uvalde for \$2 million in payments to the families and commitments from the City to better train police officers with their shooting response protocols.

We are so proud of Erin's relentless drive to be the voice for the voiceless and her advocacy on behalf of true change in policing in Uvalde. Erin believes that no child should be afraid to go to school and because of her work, the City of Uvalde will work to be better guardians of their schools. Her work ethic is unmatched, and she is a fearless advocate for those who need it most.
